This should enable the tree to maintain it's appearance as it is currently looking overgrown and unkept

The tree can be seen from the front of the property above the roof which gives a indication of the size, it also sheds branches on a regular basis indicating it is not in the best condition

The hieght also needs to be under control for fear of damage to the property

I would prefer to fell the tree and plant a number of smaller trees however I believe consent to fell the tree was refused in 2011 as it should be retained in the intrest of visual amenity
