2 - WESTERN BOUNDARY - TO ERECT A 1.8M HIGH VERTICAL FEATHER EDGE POST AND RAIL FENCE (AGRICULTURAL STYLE) FROM THE FRONT (SOUTH) TO REAR (NORTH) BOUNDARY.

3 - EASTERN BOUNDARY - TO ERECT A 1.8M HIGH VERTICAL FEATHER EDGE POST AND RAIL FENCE (AGRICULTURAL STYLE) FROM THE FRONT (SOUTH) TO REAR OF EXISTING GARAGE TO MATCH WESTERN LATERAL BOUNDARY.

4 - SOUTHERN BOUNDARY (FRONT) - TO ERECT A 1.8M HIGH TRADITIONAL WROUGHT IRON GATES

(TO BE ELECTRONICALLY OPERATED) TO BE SET IN EXISTING BRICK PILLARS. REMOVAL OF EXISTING 1.8M HIGH HEDGEROW AND TO EXTEND CURVED BRICKWORK AT THE SIDE OF EXISTING DRIVE TO EXTEND ALONG THE WHOLE LENGTH OF THE FRONT BOUNDARY TO A HEIGHT OF 1.8M. WALLING TO BE DOUBLE SKINNED IN BRICKWORK TO MATCH EXISTING BRICK WALLING AS FAR AS POSSIBLE.
