Approximately 250 m of cable will be installed from the Hornsea Project Two substation into the adjoining land owned by Orsted Power (UK) Limited (see HOW021020\_OnSS\_CableLayApplication\_20220707). Of the 250 m of cable, approximately 150 m will be installed and buried within the land adjoining the Hornsea Project Two Onshore Substation (OnSS) with the remainder retained within the boundary of the Hornsea Project Two OnSS. Burying of the cable is necessary to prevent theft. The cable will be installed under the fence line utilising an existing cable duct located approximately 1.2 m below the ground surface.

The required for the installation and burial of the cable outside of the Hornsea Project Two OnSS comprises mixed vegetation, planted to screen the substation in accordance with the Requirement 8 of the Hornsea Project Two Development Consent Order (DCO) and the Landscape Scheme and Management Plan (LSMP). Existing vegetation will be temporarily removed and stored on site. A trench, approximately 1.2 m deep, will be dug using a mechanical digger along the northern boundary (see HOW021020\_OnSS\_CableLayApplication\_20220707). Top soil and sub soil will be stored separately on site.

The cable will be installed in the trench prior to backfilling. Following installation of the cable all vegetation will be reinstated to pre works condition in accordance with the requirements set out in the LSMP.
