Identification of Tree(s) and Description of Works

The Sycamore trees have low value and poor quality with insignificant value. The trees have been overgrown in ivy for a number of years. A previous application to remove the trees was approved in October 2017 but they were unable to be felled before the Covid pandemic struck and therefore the permission lapsed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
