Please explain why you consider the existing or last use of the land is lawful, or why you consider that any existing buildings, which it is proposed to alter or extend are lawful

The development comprises the enlargement of the existing roof space through the extension of a rear dormer structure. The proposal does not involve any increase in the height of the existing roof ridge and remains subordinate to the principal roof form. The cubic content of the enlarged roof space, when taken together with any previous additions, will not exceed the volume limitations prescribed under Class B.

The dormer extension is located to the rear roof slope and does not extend beyond the plane of the existing roof slope which fronts a highway. As such, the proposal complies with the requirement that no part of the enlargement extends beyond the principal elevation of the dwellinghouse.

The proposed development will not exceed the highest part of the existing roof and the eaves height will be maintained or extended in a manner consistent with the existing dwellinghouse.

In light of the above, it is considered that the proposed development complies fully with the requirements of Schedule 2, Part 1, Class B of the Town and Country Planning (General Permitted Development) (England) Order 2015 and is therefore lawful.
