Title of Document:

North Lincolnshire Local Plan 2020-2038 Publication Draft Addendum May 2022

Subject Matter and Area Covered:

North Lincolnshire Council has prepared the North Lincolnshire Local Plan 2020-2038: Publication Draft Addendum. The Local Plan sets out the broad spatial planning and policy framework for North Lincolnshire up to 2038. The Local Plan Addendum sets out proposed focussed changes.

The Addendum draft should be read alongside the North Lincolnshire 2020-2038: Publication Draft. It is intended that both will comprise the Publication Local Plan for North Lincolnshire.

Period of Publication for Representations:

Representations are invited on the Publication Draft Addendum North Lincolnshire Local Plan for a period of 6 weeks – from 5pm Monday 30th May 2022 until 5pm on Monday 11th July 2022.

Representations:

Representations made in response to the North Lincolnshire Local Plan 2020-2038: Publication Draft are still valid and do not need to be re-submitted.

Representations are invited on whether it is agreed that the Plan meets certain tests (which will be examined at the Examination in Public). Representations at this stage should only be made on the legal and procedural compliance of the North Lincolnshire Local Plan, the soundness of the North Lincolnshire Local Plan and whether the North Lincolnshire Local Plan is in conformity with the Duty to Cooperate*.

It is recommended that representations are made by completing the Council's Publication Draft Addendum Stage Representation Online Form – with the aid of its accompanying guidance notes (which also explain what the above tests are).
