## Notice of the Submission of the North Lincolnshire Local Plan to the Secretary of State for Levelling up, Housing and Communities

On 11 November 2022, North Lincolnshire Council submitted its draft Local Plan to the Secretary of State for an Examination in Public, under Regulation 22 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

The Plan sets out the vision, objectives, spatial approach, planning policies and allocations for development within the Plan Area up to 2038. It addresses the long-term spatial development of North Lincolnshire, taking account of social, economic and environmental considerations. The Plan sets out what and where development is acceptable and, once agreed and adopted, will govern how planning applications are assessed. Once agreed (formerly adopted) it will replace the current North Lincolnshire Local Plan Adopted 2003 (saved policies), the Core Strategy and Housing and Employment Land Allocations Development Plan Documents, and the Lincolnshire Lakes Area Action Plan.

Evidence gathering and preparation of the new North Lincolnshire Local Plan began in 2017. The Council have consulted the public on five separate occasions, most recently in May 2022. Comments have been used to formulate the Plan. The Inspector will now consider those responses alongside the Plan.
