STATEMENT OF COMMON GROUND DUTY TO CO-OPERATE STRATEGIC PLANNING MATTERS TABLE, NOVEMBER 2022
Neighbouring Planning Authorities and Prescribed Bodies

Section 110 of the Localism Act, November 2011, puts in place a duty on local councils to co-operate with neighbouring councils and bodies such as the Environment Agency and National Highways (formerly Highways England) on planning matters, which cross-administrative boundaries. The duty is outlined in National Planning Policy Framework paragraphs 24 to 27 ('Maintaining effective cooperation'). In particular, it states that local planning authorities and county councils (in two-tier areas) are under a duty to co-operate with each other, and with other prescribed bodies, on strategic matters that cross administrative boundaries. Strategic policy-making authorities should collaborate to identify the relevant strategic matters which they need to address in their plans.

The table below identifies the latest analysis of matters and proposed actions suggested for discussions with relevant neighbouring LPAs regarding the new North Lincolnshire Local Plan. This information below will assist in demonstrating that the duty has been carried out appropriately.
