**Notice of adoption of the North Lincolnshire Local Development Framework – Housing & Employment Land Allocations  
Development Plan Document**

Notice is hereby given in accordance with Regulations 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, that the North Lincolnshire Local Development Framework – Housing & Employment Land Allocations Development Plan Document ('the HELADPD') was formally adopted by North Lincolnshire Council on 7 March 2016.

The HELADPD sets out which sites the council has allocated for future housing development and where new employment opportunities will be located. It also defines town and district shopping centre boundaries to show where future retail development should take place and settlement development limits. Now adopted, the HELADPD forms part of the development plan for North Lincolnshire.

The HELADPD was the subject of an independent examination conducted by an Inspector appointed by the Secretary of State. The Inspector's Report was issued in February 2016 and the recommended main modifications have been included in the HELADPD.

Any application must be made no later than six weeks after the date of adoption, i.e. by 18 April 2016.
